

# Exchange Program – Study Abroad Zurich

Full Academic Year or Spring Semester - Sponsored by the ASU Department of Economics

## Quick Facts and Highlights

- With its 26,000 enrolled students, the University of Zurich (UZH) is Switzerland's largest university.
- Founded in the year 1833, UZH was Europe's first university to be established by a democratic political system; today, UZH is one of the foremost universities in the German-speaking world.
- Made up of seven faculties covering some 100 different subject areas, the University offers a wide variety of Bachelor's, Master's and PhD programs. In addition, UZH's continuing education programs offer excellent learning opportunities.
- As a member of the "League of European Research Universities" (LERU), the University of Zurich belongs to Europe's most prestigious research institutions.
- To date, the Nobel Prize has been conferred on twelve UZH scholars.
- Zurich is the largest city in Switzerland with more than 1.8 million inhabitants, an international hub for banking and finance, and the capital of the canton of Zurich. It is located in German speaking north-central Switzerland at the northwestern tip of Lake Zurich. Zurich is a hub for railways, roads, and air traffic. Enjoy easy travel to France, Germany, Austria, and Italy.
- Get the chance to see world famous mountains Matterhorn, Mont Blanc, enjoy great skiing, and travel the famous Swiss Railroad system

## Credits

Take courses in English that fulfill ASU degree requirements. Examples of classes are Development Economics, Economic Growth, Intermediate Econometrics, International Economics, Introduction to Game Theory, Introduction to Strategic Management, Methods of Empirical Macroeconomics; additional classes may be possible. Interested students should discuss this program with their academic advisor to confirm how courses taken abroad will fulfill degree requirements.

Students can participate in an intensive German course that takes place two weeks before the beginning of the semester (\$100). Other courses are offered during the semester. The application deadlines are binding and the number of participants is limited.

## Eligibility and Cost

Minimum Class Standing: Junior, Areas of Study: Business and Economics, no German language prerequisite, GPA requirement: 3.00

The cost is estimated to be \$11,600 for a semester and \$19,455 for a whole year, which includes estimates for Airfare, Housing, Meals, Books, Personal Expenses, Health Insurance, Local Transportation, Visa, and Passport. Scholarships are available to cover part of the cost. Estimate does not include ASU tuition.
